Madam/Sir,

Kindly refer to letter No. DBS/HRMS/2019/1406 dated 16.5.2019 issued by this office vide which it was decided to roll out certain modules like GPF Management, Leave Management, Annual Property Returns, Payment Module, Income Tax module, MIS etc. of the i-HRMS. The modules have since been successfully rolled out through out all the Administrative Departments (ADs) of the Govt. of Punjab.

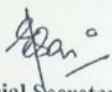
2. It has now been decided to develop and roll out the additional modules in i-HRMS as well as a Property Registry System. Accordingly, the fields pertaining to the entry of information of the location of officers of Government of Punjab in terms of their latitude and longitude details has been made active and mandatory in i-HRMS.

3. You are, therefore, requested to direct all the Heads of Departments, DDOs etc. under the AD to enter the said details with regard to the exact location of the office in i-HRMS by

10th of July, 2020 lest the access to salary module of the offices who fail to enter these details by the stipulated date will be automatically denied in i-HRMS.

4. The detailed procedure to enter the location details of the offices has been made live on i-HRMS and is also annexed with this letter for ready reference.
